SPEAKER SPONSOR



Abby Phillip is a senior political correspondent and anchor of CNN's Inside Politics Sunday. She joined the network in 2017, serving as White House Correspondent through 2019. In 2020, she moderated CNN's Democratic Presidential Debate and anchored special coverage of Election Night in America.

Previously, Phillip was a reporter for the Washington Post, where she covered domestic and international news including the shootings in Charleston, SC and San Bernardino, CA. Previously, Phillip was a digital reporter at ABC News and covered the Obama White House for Politico.

Phillip is working on her first book - a major contemporary look at the life and political legacy of Jesse Jackson. It includes "origins of how Black voters got to be the kingmaker in the Democratic primary," Phillip says. "It is a story about the building blocks of the present-day Democratic party. And it's not just about race; it's also about the progressivism-versus-more-moderate debate that we're still having today."

Phillip was raised in Bowie, Md. and is a graduate of Harvard University with a degree in Government. She currently lives in Washington with her husband and their new baby girl who was born in August.

Dr. Joan M. Prince was nominated by President Barack Obama as alternate representative to the 67th United Nations General Assembly, with the honorary rank of ambassador and senior advisor to the State Department. In her professional career, Dr. Prince served as Vice Chancellor at the UWM,

and was the Chief Administrator for the Divisions of Global Inclusion/ Engagement and Partnerships/Innovation. She also led campus-wide project areas, and her academic discipline as a clinical associate professor was in medical laboratory sciences, with a specialty in hematology. Dr. Prince is now working with executives on the issues that "keep them up at night!" as CEO of Executive Strategies Elite.

Prince is a former member of numerous civic boards, including the Greater Milwaukee Foundation, Milwaukee Public Library, TEMPO International, The Council on Foundations and Urban Libraries Council.


